

What Does the Fund Invest in?

The fund will invest in fixed-income securities issued by the Canadian and US governments, financial institutions, and corporations. The fund is limited to a maximum exposure of 20% of net asset value to investments in US securities issued in foreign markets. The objective is to generate long-term positive returns exceeding ICE Bank of America Canada Corporate Index.

The charts below give you a snapshot of the fund's investments on September 30, 2024. The fund's investments will change.


Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how Series A securities of the fund have performed since inception. Returns are after expenses have been deducted. These expenses reduce returns. This information is not available because the fund is new.

Year-by-year returns

This chart shows how Series A securities of the fund have performed since inception. The range of returns and changes from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series A securities of the fund in a 3-month period since inception. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series A of the fund since inception would have had \$1000.10 as of September 30, 2024. This is equal to an annual compounded return of approximately 0.01%.

Who is this fund for?

Investors who:

- You are seeking capital preservation and income
- You are looking for a Canadian fixed-income fund to hold as part of their diversified portfolio
- You plan to hold your investment for the medium term or longer; and
- You can tolerate a low to medium level of risk.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A securities of the fund.

The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales Charge Option

What you pay in percentage terms

Initial Sales Charge

0% - 2.5% of your purchase price

In Dollars

\$0 to \$25 is deducted from every \$1,000 you invest

How It Works

- You and your representative decide on the initial sales charge amount.
- The initial sales charge is deducted from the amount you invest. It goes to your representative's firm as a commission.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

The fund's expenses are made up of the management fee,

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your representative and their firm provide to you.

operating expenses and trading costs. The Series A annual management fee is 0.64% of the Series A net asset value. As of June 15, 2024, the fund's expenses were as below:

	Annual rate (as a % of the fund's value) Series A
Management expense ratio (MER) This is the total of the management fee (including the trailing commission), fixed administration fee, and fund costs	1.02%
Trading expense ratio These are the fund's trading costs	0.05%
Fund expense	1.07%
For every \$1,000 invested, this equals to:	\$10.70

DAMI pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment. The rate depends on the series you choose.

For Series A units of the fund, DAMI pays your dealer firm an annual trailing commission of 0.25% for as long as you own the fund. This equals \$2.50 each year for every \$1,000 held

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch funds' securities.

Fee: What you pay.

Account fee	If you switch between series of the Fund or to another DAMI fund, then you may pay your representative's firm a switch fee of 0-2%.
Short-term trading fee	A fee of 2% of the amount switched or redeemed will be charged by the Fund if you invest in the Fund for less than 30 days. This fee goes to the fund.
Switch fee	If you switch to another DAMI fund, then you may pay your representative's firm a switch fee of 0-2%.
Change fee	If you change between another series of the Fund, then you may pay your representative's firm a change fee of 0-2%.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document or
- cancel your purchase within 48 hours after you receive confirmation of the purchase. In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
